### RACES

Race 1 – Reviewed the second quarter (:27.4, :59) set by #5 Enchanted Angel (Bob McClure) – McClure has the whip up and is waving it at the filly to keep her going while on the lead. No violation of AGCO Rule 22.05.01(k) by McClure.

Race 2 – Spoke to Scott Young (#1 Gone Goodbye) about pulling and not advancing in the second quarter.

Race 3 – #7 Sporty Liz (Doug McNair) is wandering in the stretch and ticked the wheel of #4 Le Bec Fin (Austin Sorrie). #7 charted with interference and causes interference to #8 Definingthe Moment (Bob McClure). #7 finished 6<sup>th</sup> placed 8<sup>th</sup> for interference.

Page 2 Race 4 – Inquiry – Reviewed the break by #3 Sid The Kid (Mario Baillaregon) before the start – not inside the Fair Start Pole, Refund \$42,601. Inquiry video unavailable.

Race 5 – #4 We Believin (Bob McClure) was charted with interference due to the break by #2 Lockdownthecrowd (Brett Macdonald) in the third quarter, no placings needed.

Race 6 – Inquiry X 2
