



FALL EXTRAVAGANZA MIXED SALE

SC Sale Pavilion at Flamboro Downs

Thank you for your entry/entries for the *Fall Extravaganza Mixed Sale* that will take place on **Sunday, October 23, 2011**.

There are some things that need to be taken care of before the sale. These things are required in order to sell your horse(s).

REQUIRED DOCUMENTATION

1. SIGNED TRANSFER OF OWNERSHIP

All owners must be in agreement of the sale of your horse(s) and must certify the agreement by signing a transfer of ownership form. This form is attached.

Please fax or scan and email this signed form back to the SC Sales Department by Friday, October 21st at the latest.

Please note that signatures from all owners must be received prior to the sale in order for the horse to enter the sale ring. YOUR HORSE WILL BE WITHDRAWN FROM THE SALE IF WE DO NOT HAVE SIGNED TRANSFERS.

If your horse has a registration certificate please bring it with you to the sale and deliver to the Sales Office.

If your horse is on "electronic" registration only the signatures as stated above are required.

2. ORIGINAL HARD COPY OF COGGINS TEST

All Coggins Tests must be dated after **MAY 15, 2011**.

The original hard copy of the Coggins test is required. This is a condition of sale, if this is not provided there will be a \$100 documentation penalty fee and also it will deter U.S. buyers from bidding on your horse as they will not be able to cross the border without an updated hard copy Coggins test.

Please bring the original hard copy with you to the sale and deliver to the Sales Office so that it can accompany the horse after it is sold.

FOR BROODMARES ONLY

In addition to #1 and #2 above, broodmares must have the following documentation.

3. BROODMARE PREGNANCY REPORT

Each broodmare must be checked by a veterinarian to confirm pregnancy status before the sale.

Vet checks must be done within one week of the sale (between October 16th and October 23rd). The broodmare report form is attached.

Please fax or scan and email the broodmare report(s) to the SC Sales Department prior to 4:00 pm on Friday, October 21st.

If your vet report is not ready at that time, please bring it to the sale with you and deliver to the Sales Office.

4. CERTIFICATE OF SERVICE

If your broodmare is IN FOAL, please ensure that the mating certificate is on file with SC.

If we do not have the certificate before Friday, October 21st, please bring it to the sale with you and deliver to the Sales Office.

MISSING PAPERWORK

If paperwork is missing, a \$100.00 administration fee will be deducted from sale proceeds for each document (as per Section 24 of the sale contract).

Below is some important information that you will need to know in order to make the sale day hassle free for consignors, buyers and the sale company.

SHIPPING IN

We encourage you to ship your consignment to the Sale Pavilion on Saturday, October 22nd. Stalls will be available for ship-in after 12:00 noon.

**All horses must be in their stalls and ready to sell at
9:00 a.m. on sale day.**

PARKING

Consignor **vehicles** can be parked in the designated area on the north side of the Sale Pavilion;

HOWEVER

Horse **trailers** must be parked in the area adjacent to the Flamboro Race Office (outside the gate).

There will be no exceptions to this rule.

The parking rules will be strictly enforced for the safety of horses and people and to ensure a steady traffic flow.

If you are unsure where to park your vehicle or horse trailer, please ask a parking attendant or Flamboro security personnel. Harassment of parking personnel will not be tolerated.

If you choose to park in an area that is not designated for consignors, your vehicle/trailer will be removed at your expense.

A traffic flow chart is attached.

HORSES WITHDRAWN FROM SALE

Once the catalogue is printed you are responsible for the entire entry fee if your horse is withdrawn from the sale. The only exception to this rule is if the horse you entered is claimed or deceased, in these cases, the fee will be \$250.00. A deceased horse must be verified with a signed letter from a veterinarian.

If your horse is out of the sale, please advise the Sales Department immediately.
