GENERAL DIRECTIVE No. 4-2009 Annual Racetrack Licence Fee

Pursuant to Section 7(f) of the *Racing Commission Act, 2000*, this directive sets the Annual Racetrack Licence Fee for the Ontario Racing Commission fiscal year 2009-2010, as part of the fees and other application charges applicable to a Licence to Operate a Racetrack. The fee is expressed as a monthly charge, calculated based on the portion of the total purses paid at each track for the 2008 racing season and is effective April 1, 2009.
