#### Races:

#6 did finish with broken equipment (overcheck).

**Race #4** – Clear - Ed Hensley does use more than acceptable wrist action while urging "Andy Over" in the final quarter of the race. Mr. Hensley was found in violation of AGCO rule 22.23.03(b) and issued a \$300.00 monetary and a five-day driving suspension April 10-14, 2024 (inclusive). Ruling #2604437.
