 - o If horse has electronic registration, only a signed transfer form is required.
 - o NO HORSE WILL BE SOLD WITHOUT A SIGNED TRANSFER FROM ALL OWNERS.
- ✓ Hard Copy of Coggins Test dated within 180 days of sale.
 - Fall Extravaganza Mixed Sale Coggins date May 15, 2015
- ✓ Broodmare Pregnancy Report & Certificate of Service
 - Please fax or e-mail your pregnancy reports to SC prior to the sale if possible.
 - o Pregnancy reports signed by a veterinarian must be dated within one (1) week of sale.
 - Fall Extravaganza Mixed Sale Pregnancy report date October 11, 2015

STABLE AREA

- Stall allocation is listed in the catalogue (please advise shipping personnel of your location).
- YOU ARE STRONGLY ENCOURAGED TO SHIP YOUR HORSES IN THE AFTERNOON BEFORE SALE DAY.
- ALL HORSES MUST BE SHIPPED IN AND READY TO SELL AT 9:00 A.M. ON SALE DAY.

GENERAL INFORMATION

The entry fee is non-refundable as per Condition 3 of the sale contract.

If a horse is withdrawn on the **account of death** or **claimed from a claiming race** after cataloguing, the entry fee will be \$300.00.

- Reserve bids will not be taken by SC for any horses in the sale.
- Park consignor vehicles and horse trailers beside the Race Office. NO EXCEPTIONS to this policy.
- Each stall will be bedded with straw; additional straw is available at the end of the shed rows.
- · Hay is provided but consignors are responsible to provide grain and feed supplements.
- Standardbred Canada does not supply any stable equipment, please bring your own.
- · Concrete pads outside of certain rows are to be used for manure only.
- Blue garbage barrels are to be used for garbage only.
- · All horses must be freeze branded. An ID technician will be available at the sale if it is not already done.
- Pedigrees will be placed in plastic pouches on each stall door. Please <u>do not remove the plastic pouches</u> from stall doors. Stall doors must be returned to their <u>original state</u> after the sale.
- Consignors must bring horses to the sale walking ring eight (8) horses in advance and returned to their stall after they are sold. The sale halter must be left on each horse for the new owner.
- Horses must be brought to the ring with either a chiffney bit or lead shank over the nose.
- Standardbred Canada personnel will lead horses in the auction ring.

CATALOGUES & UPDATES

- The main catalogue will be online 10 days prior to the sale at www.standardbredcanada.ca under "Sales".
- Supplement catalogues will be available online five (5) days prior to the sale.
- Due to the short timeline to prepare the catalogue after entries closing, catalogues will not be mailed.
- Catalogues will be available at racetracks that are racing, Wilson Tack outlets and some training centres.
- Updates and corrections to the sale catalogue will be accepted on the Catalogue Update form. If received, this information will be entered into the Pedigree Reader's official catalogue.
- All racelines will be included in the Main sale catalogue.
- Any additional racelines will appear in the Supplement sale catalogue and will be posted on stall doors.
