Trainer Pat Dillon requested to be upgraded to an "A" license. Request granted.

## Races:

Race 1: Breath test strip utilized. Clear.

Race 2: Driver's Objection: #5 Peanutbettornjelly (J. Woodward), finished 6th, on #7 Lilly United (B.Reibeling), finished 5<sup>th</sup>, before the quarter mile mark. Objection disallowed.

#8 Ultimate Speed (S.Hudon) was charted with an interference from the break of #5 Peanutbettornjelly.

#5 Peanutbettornjelly must qualify for breaks. (2 in a row on a fast track)

Reviewed the break of #3 Lady Bonita after the three-quarter mark.

Race 3: Breath test strip utilized. Prospect Series 2y/o Pacing Colts. Clear.

Race 4: Recall charged to #4 Dream Of Jeannie for causing interference to #3 Mae Lose Control before the start.

#2 Senior Advisor was charted with interference at the five eighths mile mark due to #3 Mae Lose Control stopping abruptly in front of #2 Senior Advisor.

#3 Mae Lose Control must qualify for performance as the horse was distanced.

**Race 5:** Reviewed possible pylon violation of #1 Rambaran Rose (R.Gassien), before the half mile mark, it was determined that the race bike was not inside any pylons and had hit three, no violations of the AGCO pylon rules.

Stephane Pouliot was in violation of AGCO rule 22.23.03 (did use more than acceptable wrist action while urging). Ruling # 1868439 - \$300 monetary penalty and a five-day driving suspension September 23<sup>rd</sup> to September 27<sup>th</sup> inclusive. (second offence within a one-year period)

Race 6: Clear.

**Race 7:** Judges' Inquiry: Third place finisher #3 Voss Volo (N. Boyd) made a break before and after the start. No violations of the AGCO breaking rules including the extended breaking rule. (25 or more strides after the start)

#1 Mystery Bet (M.Jones) must qualify for performance as the horse made a break before the quarter mile mark and pulled up behind the starting gate after the half mile mark. Mystery Bet was charted "did not finish" and 5<sup>th</sup> place money was retained by the association.

Race 8: Prospect Series 2 y/o Pacing Fillies. Clear.

**Race 9:** Judges' Inquiry: #4 Amazon Dragon (B. Reibeling) stepped onto the wheel of #3 Thorn In The Side (D. Brown) before the three-quarter pole. #4 Amazon Dragon finished 4<sup>th</sup> and was place 6<sup>th</sup> for striking the wheel of another race bike. #4 Amazon Dragon was charted with an interference break and #3 Thorn In The Side was charted with interference.

Braiden Reibeling was found in violation of rule 22.05.01(h), striking the wheel of another race bike. He was issued a three-day driving suspension, September 24<sup>th</sup> to September 26<sup>th</sup> inclusive. Ruling #1868452.

Race 10: Recall charged to #6 High Rolling A due to possible broken equipment before the start.
